

#### **OBJECTIVES OF THE PORTAL**

Objectives of the EducationINdia Portal (educationindia.gov.in) are as follows:

- To showcase the strength of Indian education system to foreign students;
- To provide a common platform to Indian institutions to showcase their strengths to foreign students;
- To attract more foreign students to study in India;
- > To maintain a common database of foreign students.

### **GENESIS**

- India has been famous at the global stage for its unique culture of 'Atithi Devo Bhava'. This attribute has significantly been helpful in attracting foreign students to study in India who have considered India a treasure trove of education for thousands of years.
- Foreign students in huge number from around the world partake in study in the Indian educational institutions, and benefit from this Indian educational wealth.
- In recent times, National Education Policy 2020 (NEP-2020) has emphasized upon making India an attractive educational destination for the foreign students, and upon promoting India as a global educational destination offering premium as well as unique education in an affordable manner.
- At a time when the focus of the Indian government is on transforming India into a hub of higher education for the foreign students, the significance of showcasing the strength of Indian educational system and Indian educational institutions to foreign students at one place has only increased.

- Countries such as USA with the efforts 'STUDY IN THE STATES (<u>https://studyinthestates.dhs.gov</u>)' have attempted to improve service tied to regulations governing international students studying in the USA, clearly explaining the student visa process, enhancing coordination among government agencies, and keeping international students and the US academic community better informed about pertinent rules and regulations.
- Similarly, CAMPUS FRANCE (https://www.campusfrance.org/en) is the French Agency for the promotion of higher education, international student services, reception and international mobility. It is a public institution (EPIC) responsible for promoting higher education, hosting and managing the international mobility of students, researchers, experts and guests to promote French higher education throughout the world.
- In present scenario of India, there exist multiple portals containing information for and about foreign students willing to study in India, and are being managed by different Bodies and Agencies.
- An urgent need, therefore, is felt to have a common portal through which the strength of Indian education system and Indian institutions be showcased to foreign students for attracting them in larger number by means of providing necessary facilitation, and also maintaining their common database, at one place.

#### **GUIDANCE FROM NEP-2020**

- New National Education Policy which came into existence in the 2020 (NEP-2020) envisioned transformational changes in the educational landscape of India.
- The objectives and the provisions contained in the NEP 2020 highlight that

Providing universal access to quality education is the key to India's continued ascent, and leadership on the global stage in terms of economic growth, social justice and equality, scientific advancement, national integration, and cultural preservation. Universal high-quality education is the best way forward for developing and maximizing our country's rich talents and resources for the good of the individual, the society, the country, and the world. India will have the highest population of young people in the world over the next decade, and our ability to provide high-quality educational opportunities to them will determine the future of our country.

The para (s) in the NEP-2020 relevant to the project of EducationINdia Portal are reproduced hereunder

#### Para 4.20.

In addition to high quality offerings in Indian languages and English, foreign languages, such as Korean, Japanese, Thai, French, German, Spanish, Portuguese, and Russian, will also be offered at the secondary level, for students to learn about the cultures of the world and to enrich their global knowledge and mobility according to their own interests and aspirations.

#### Para 12.7.

The various initiatives mentioned above will also help in having larger numbers of international students studying in India, and provide greater mobility to students in India who may wish to visit, study at, transfer credits to, or carry out research at institutions abroad, and vice versa. Courses and programmes in subjects, such as Indology, Indian languages, AYUSH systems of medicine, yoga, arts, music, history, culture, and modern India, internationally relevant curricula in the sciences, social sciences, and beyond, meaningful opportunities for social engagement, quality residential facilities and on-campus support, etc. will be fostered to attain

this goal of global quality standards, attract greater numbers of international students, and achieve the goal of 'internationalization at home'.

#### Para 12.8.

*India will be promoted as a global study destination providing* premium education at affordable costs thereby helping to restore its role as a Vishwa Guru. An International Students Office at each HEI hosting foreign students will be set up to coordinate all matters relating to welcoming and supporting arriving from *Research/teaching* abroad. students collaborations and faculty/student exchanges with highquality foreign institutions will be facilitated, and relevant mutually beneficial MOUs with foreign countries will be High performing Indian universities will signed. be encouraged to set up campuses in other countries, and similarly, selected universities e.g., those from among the top 100 universities in the world will be facilitated to operate in India. A legislative framework facilitating such entry will be put in place, and such universities will be given special dispensation regarding regulatory, governance, and content norms on par with other autonomous institutions of India. Furthermore, research collaboration and student exchanges between Indian institutions and global institutions will be promoted through special efforts. Credits acquired in foreign universities will be permitted, where appropriate as per the requirements of each HEI, to be counted for the award of a degree.

#### Para 17.4.

The societal challenges that India needs to address today, such as access for all its citizens to clean drinking water and sanitation, quality education and healthcare, improved transportation, air quality, energy, and infrastructure, will require the implementation of approaches and solutions that are not only informed by top-notch science and technology but are also rooted in a deep understanding of the social sciences and humanities and the various socio-cultural and environmental dimensions of the nation. Facing and addressing these challenges will require high-quality interdisciplinary research across fields that must be done in India and cannot simply be imported; the ability to conduct one 's own research also enables a country to much more easily import and adapt relevant research from abroad.

### **INTRODUCTION**

- The encouragements enshrined in the NEP-2020 for planning and acting towards providing universal access to quality education are the key for India to provide much desired leadership to the world with the proven ability of providing quality educational opportunities.
- EducationINdia Portal will offer immense potentialities in attracting larger numbers of students from across the globe to study in India, providing information and motivations to the foreign students willing to study in India or undertake research at an Indian institution, leading further towards attainment of the goal of *internationalization at home*'.
- EducationINdia Portal has huge potential to help India promote itself as a global study destination providing premium education at affordable costs.
- EducationINdia Portal intends to showcase the strength of Indian education system to attract foreign students and through this portal, Indian institutions admitting or desirous of admitting foreign students will get a common platform to showcase their strengths to the foreign students.
- The availability of the data with respect to Indian institutions admitting foreign students on different platforms would also be put to the best use which would be integrated automatically by means of API or through user credentials of different institutions or other similar ways from various Educational, Fellowship Granting, Accreditation and Regulatory bodies.
- There will exist the flexibility in EducationINdia Portal for foreign students to search and view the available educational opportunities in India without registration.

- Registration, however, will mandatorily be required on EducationINdia Portal for the purpose of generating a unique Education India ID (EI-ID) to get admission in Indian institutions.
- All the existing portals managed by various Ministries/Bodies of Government of India would continue to have control over their sovereign functions without any interference from EducationINdia Portal.
- The details of student Visas for education available with MHA would be mutually helpful for the information to be provided in this portal in terms of cross verification, ensuring at the same time that its portal will not interact directly with any other secure system but help other systems by providing data as per their need.
- EducationINdia Portal will collate information from various Bodies of the Government, and register all the institutions admitting foreign students. These Institutions/Bodies upon registration will be in receipt of the login credentials to update their data or supply more information in future.
- EducationINdia Portal will facilitate the foreign students and also the Indian institutions without affecting their functioning and will only help them by providing information.
- EducationINdia will facilitate foreign students in getting good quality education as per their preference and convenience.
- EducationINdia will facilitate Indian institutions in taking the help of this portal to provide better opportunities to the foreign students through offering the details of various programmes.
- EducationINdia Portal will be the single portal for all the programmes of education imparted by all the Indian Institutions whenever foreign students want to pursue irrespective of the stream/discipline, be it Medical, Engineering, Technology, Arts, Commerce, Management, Science etc.

- Scholarships/Fellowships provided to foreign students by various Departments/ Organizations of GoI will also be part of the EducationINdia portal.
- EducationINdia Portal will be managed and coordinated by AICTE with the support of various Bodies under different Ministries, after completing its development and making it functional.
- AICTE shall be reporting the progress with respect to EducationINdia Portal to MoE on regular basis.
- EducationINdia Portal will facilitate interactions among different Bodies of various Ministries such as Foreigners Regional Registration Offices (FRRO), Visa Issuing Authority, Immigration Agencies etc.
- Other related Ministries will be able to communicate with MoE through this portal facilitating them to stay connected without or with least human interactions, providing ease of doing business.
- EducationINdia Portal will also be applicable for the foreign students coming from the countries which do not need visa to join the educational programme in India.
- EducationINdia Portal will maintain the database in terms of Registered on the Portal, Admission offer received, Admission offer accepted, Admission completed, Programmes pursuing, Left, Passed, Alumni, Job status, Resident status etc. - of the foreign students connected through this portal which will be useful for different stakeholders.
- The available information can provide an opportunity to MoE for enhancing collaboration with other Ministries and various stakeholders, in restoring the role of India as a 'Vishwa Guru'.

#### **Study in the States**

The US Department of Homeland Security (DHS) has launched '**Study in the States**' to enhance national security and improve customer service tied to regulations governing international students studying in the USA. It clearly explains the student visa process, enhances coordination among government agencies, and keeps international students and the US academic community better informed about pertinent rules and regulations. The website (<u>https://studyinthestates.dhs.gov</u>) serves as a dedicated resource to help schools and programmes in the US, along with international students, navigating the international student life cycle. Users find important information from various federal agencies that play a role in implementing student visa and exchange visitor programs, including:

- U.S. Immigration and Customs Enforcement, Student and Exchange Visitor Program (SEVP).
- DHS' Office of Academic Engagement.
- U.S. Citizenship and Immigration Services.
- U.S. Customs and Border Protection.
- Department of State's Bureau of Consular Affairs.
- Department of State's Bureau of Educational and Cultural Affairs.

The website provides clear, easy-to-follow language that helps all students, schools and programs understand and comply with federal regulations.

#### **Provider Registration and International Student Management System (PRISMS)**


The Department of Education, Skills and Employment is responsible for the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS). Only education institutions registered under the Education Services for Overseas Students Act 2000 and listed on CRICOS can enroll overseas students to study in Australia on a student visa. **'PRISMS** (https://prisms.education.gov.au)' is a computer system developed by the Department in association with the Department of Home Affairs for the purpose of receiving and storing information about accepted overseas students. PRISMS provides a secure system to comply

with legislative requirements by issuing bona fide confirmations of enrolments as "evidence of enrolment" in a registered full-time course as required for the issue of a student visa by Home Affairs, and reporting changes in course enrolment, particularly where study ceases (noncompliance), or the duration of the study changes. This also facilitates the monitoring of student compliance with visa conditions and provider compliance with the ESOS Act. The Department grants access to PRISMS to Providers and their Authorized Users.

It supports higher education and research establishments in their international development through events promoting higher education in France and abroad.




### **FOREIGN STUDENTS IN INDIAN HIGHER EDUCATION**

As per AISHE Annual Report 2019-20, the total number of foreign students enrolled in higher education is 49,348. The foreign students come from 168 different countries from all across the globe. The highest number of foreign students are enrolled in UG Courses, i.e. 74.3% of the total foreign students, followed by PG i.e. 16.6% enrolment.

Enrolment in rest of the levels constitutes 9.1%. Foreign Male students are higher in almost all the levels. Highest share of foreign students come from the neighboring countries of which Nepal constitutes 28.1% of the total, followed by Afghanistan 9.1%, Bangladesh 4.6%, Bhutan 3.8% and Sudan 3.6%. (*Source: AISHE Annual Report 2019-20*). If we consider the student strength of other bodies also, this number will increase further.



# **PROCESS FLOW**

**URL** for this EducationINdia Portal is educationindia.gov.in.

#### **Foreign Students**

- No registration will be required for browsing through EducationINdia Portal and using the features like filtering criteria and seeing the details of various institutions.
- After registering on EducationINdia Portal, foreign student will be allotted a Unique EducationINdia portal ID (EI-ID).
- It would be mandatory for foreign student to register on EducationINdia Portal to seek admission in any of the Indian institutions.

- It would be mandatory for foreign student to register on EducationINdia Portal for issuance of visa, and at the time of applying for visa, quoting the EI-ID generated through this portal will be mandatory.
- EI-ID will be asked by MEA/ MHA/ FRRO/ Visa authorities while applying for Visa or/and immigration related functions. EI-ID may be verified through separate login on EducationINdia Portal before issuance of Visa.
- After joining the programme, the foreign student will update his details, including his address in India on EducationINdia Portal.
- A similar process of confirmation through EducationINdia Portal will follow when the student applies for FRRO registration.

#### **Indian Institutions**

- It would be mandatory for an Indian institution, willing to admit any foreign student, to register on EducationINdia Portal.
- Before issuing the offer of admission, the Indian institution will advise the foreign student to register on EducationINdia Portal and this will be mandatory for issuance of Visa.
- Once the student gets admitted, the Indian institution will update EducationINdia Portal and provide details of the programme in which foreign student has been admitted.
- After registration of Indian institutions on EducationINdia Portal, their login credentials will be shared with them to update their data or provide more information.
- It will be mandatory for Indian institutions to fill details of all foreign students admitted by them on EducationINdia Portal through their login and verify/ update these details as and when required.

#### **Implementing Bodies**

- Login credentials to verify and/or get details of EI-ID will be given to various Bodies/ Ministries for authentication and other purposes.
- EducationINdia Portal will collect such data, through API from various Bodies/ Ministries i.e. AICTE, AISHE, ICCR, SII, UGC, NAAC, NBA etc. and register all these institutions on EducationINdia Portal. Data of Indian institutions admitting foreign students is already available on various platforms and submitted by the institutes.
- Details of various scholarships, including those of ICCR, SII will be provided on EducationINdia Portal.
- EducationINdia Portal will not interfere in admission process of foreign students. The admission will be carried out by concerned institution/ organization as per their prevailing norms.
- Visa issuing office/portal will communicate through API with EducationINdia Portal using the EI-ID of the foreign student to verify the offer of admission.
- In case the Institute has not updated the admission details of the student, EducationINdia Portal will ascertain it from the Institute.
- Visa will be issued only after getting a confirmation of admission through EducationINdia Portal.

- Browsing details of Indian institutions
- Foreign student or anyone else without any registration

#### Admitting any foreign student

- Indian institutions shall be registered on this portal and, already available data with various bodies/ portals shall be captured.
- Indian institute to mandatorily update their information on portal to showcase their strength.

#### Issuing of VISA

- Foreign student to register on this portal for issuance of visa
- Foreign students to mandatorily quote the EI-ID while applying for visa.

#### Updation by Indian Institution

- Indian institution to mandatorily provide the details of the programme in which foreign student(s) are admitted
- Indian institution to mandatorily update/verify details in respect of foreign students on the portal in their logins

#### Update by Foreign Student on the portal

• After joining the programme, the foreign students to update their details

#### FRRO

FRRO to verify/update the details EducationINdia through API or login credentials.

#### **BENEFITS**

EducationINdia Portal is expected to be the Brand for the Higher Education in India for Foreign students. The information of foreign students studying or willing to study in India will be available on a single platform. A glimpse of the stakeholder wise benefits is illustrated hereunder:

#### **Foreign Students**

All the information related to the programmes being run by various Indian Institutions and available on offer for foreign students will be available on a single platform to facilitate them to search and select appropriate programme to study at an appropriate place in India.

#### **Indian Educational Institutions**

Indian institutions will get a common platform to showcase their strengths. EducationINdia Portal will help them to get more foreign students.

#### **Ministry of Home Affairs (MHA)**

Using EducationINdia Portal all information related to foreign students can be tracked along with their current and updated status.

#### **Ministry of External Affairs (MEA)**

Details of the foreign students residing in India for the purpose of study in India at any point of time will be available at one place. It will also have the database of alumni. It may be made available with the Indian Missions across the globe helping them in reaching out to them.

#### Visa Issuing Authority/ FRRO/ Immigration Agencies

Current status of student (i.e., admitted with institution details, admission offer received/ accepted etc.) can easily be monitored. All updated status (course duration in terms of completed and remaining etc.) will be available on the portal and can be accessed by API or login credentials.

#### **Accreditation/ Regulatory/Ranking bodies**

Information related to foreign students can be shared/ validated through this portal.

#### **Bodies such as ICCR and EdCIL**

EducationINdia Portal will help in their existing exercise by providing more enhanced and accurate information.

### **ROLES AND RESPONSIBILITIES**

#### All India Council for Technical Education (AICTE)

- Development and Management of EducationINdia Portal;
- Coordination with various Bodies under different Ministries for receiving/providing and uploading the updated information of foreign students/Indian Institutions on EducationINdia Portal;
- Execution of EducationINdia initiative.

#### **Indian Council for Cultural Relations (ICCR)**

- Sharing relevant information related to Indian Institution/ Foreign Students between Admissions to Alumni (A2A) Portal and EducationINdia (EII) Portal;
- Making EI-ID mandatory for the foreign student seeking Scholarship/Fellowship Grant.

#### **Educational Consultants India Limited (EdCIL)**

- Sharing relevant information related to Indian Institution/Foreign Students between Study in India (SII) Portal and EducationINdia Portal;
- Making EI-ID mandatory for the foreign student seeking Admission/Scholarship/Fellowship Grant.

### **University Grant Commission (UGC)**

- Sharing relevant information related to Indian Institution/Foreign Students between UGC and EducationINdia Portal;
- Making EI-ID mandatory for the foreign student seeking Admission/Scholarship/Fellowship Grant.

#### Accreditation/Ranking Bodies (NIRF, NAAC, NBA etc.)

• Sharing information related to Indian Institution/Foreign Students between their portals and EducationINdia Portal;

• Verifying/Confirming Ranking/Accreditation status of Indian Institutions.

#### **Indian Institutions**

- Registering on EducationINdia Portal in case of willing to admit Foreign Student using its AISHE Code;
- Making it mandatory to use EI-ID and therefore advising Foreign students to register on the portal and generate EI-ID for admission;
- Verifying and Updating relevant details related to the foreign student after their admission.

#### **Ministry of Education (MoE)**

- Coordinating with various Ministries of Government of India;
- Exercising overall control and ensuring continuous monitoring.

#### **Ministry of External Affairs (MEA)**

- Making it mandatory for the FRRO/Visa authorities/ Missions to seek EI-ID while applying for Visa or/and immigration related functions;
- Verifying EI-ID using login credentials before issuance of Visa.

#### NAD & ABC

• Verifying of completed credits and degree/diploma certificates.

### **MODULES**

#### **Foreign Students**

At the time of registering on this portal, foreign students will be required to provide general information related to Personal Profile relevant for securing admission in a programme offered by any Indian institution to generate a unique EI-ID. Following are the important steps for the foreign students:

- Register with EducationINdia Portal;
- Choose the Programme;
- Choose the Indian Institution;
- Get in Touch with the Indian Institution;
- Apply for Admission on the Indian Institution's Admission Portal.



### **For Foreign Students**

#### **Generation of the Student ID (EI-ID)**

EI-ID is a unique registered id which will be provided to those foreign students who will register on EII portal. EI-ID will be a 12-digit numeric unique id which will be generated on the basis of the year of registration, country code and a running serial number for that year.

# Foreign Student ID (EI-ID)



First 2 digits will be indicate the year in which student will be register on portal.

These 4 digits will show the country code in numeric way.

These 6 digits will be indicate the serial no. of the student registration for mentioned country for mentioned year.

12 digit unique number will be used for EI-ID for the Student.




First student register from Hong Kong in year 2022, he will get the above 12 digit EI-ID. This EI-ID will be proposed to be filled by candidate for issuance of visa

#### **Indian Institutions**

Indian Institutions will register on EducationINdia Portal by providing the general information with respect to the institution, Authorities, Programme, Placement, Specific Strength to attract foreign students, Facilities, Rankings and Accreditations, Distance from the Nearest Airport/ Railway Station etc. Following are the important steps for the Indian institutions:

- Login with Credentials using AISHE code;
- Update Details on the EducationINdia Portal to showcase strength to attract foreign students;
- Contact Students to start Admission Process for Foreign Students as per the prevailing norms and using EI-ID
- Validate Student Records
- Keep updating EducationINdia Portal using login credentials or API.



### **OVERVIEW OF THE PORTAL**

#### **Institution Details**

**Institute of National Importance:** With the help of this, student can filter on the basis of whether it is institute of national importance.


States: Student can check location of the institute in state/union territory.
