CODE OF CONDUCT

Students will follow the code of conduct of college for maintenance of safe and secure learning environment. Each and every student is required;

- 1. To come to the college in prescribed uniform/dress.
- 2. To wear Identity card issued by the college.
- 3. To be punctual.
- 4. To inform the college in writing about any change in particulars related to him / her, already submitted to the college.
- 5. Not to leave college premises during college hour without prior permission of competent authority.
- 6. To take proper care of the Campus properly and to help in keeping the premises neat and clean.
- 7. Not to indulge in unsocial and illegal activities which include but not limited to ragging, drug, copying, theft, fighting, misbehavior, items which may be injurious to the body and/ or damage to property, behaving against interest of college, submission of false/ fake information/ document(s), misuse of any kind of media, disturbing and harassing others, taking part in current politics, meeting with outsiders in the college, loitering, violation of rules of the college.
- 8. To respect laws, human rights, cultural and social values.
- 9. To pay fees and clear all dues of the college in time. It is must to submit No-Dues certificate in the format prescribed by the college before leaving the college.
- 10. To follow rules, instructions and directions of the college issued from time to time.

DISCIPLINARY RULES AGAINST VIOLATION OF CODE OF CONDUCT (Ragging, Drugs, Unfair means, Theft, Fight, Misbehaviors, Misuse, Harm to property, Uniform, Others)

In the event of involvement of any student in the activities of violation of rules of the college, directly or indirectly, necessary disciplinary action against the accused student will be taken. The guilty student shall be liable for advice, warning, fine, debarring, expulsion or any other as deemed fit according to the gravity of the misconduct. Action shall be taken by concerned college authorities as per the following policy of disciplinary action against students.

Any act of use of fighting language which includes but not limited to derogatory / foul / threatening / intimidating or offensive / indecent behavior or language / speechetc.

Suspension and enquiry – Fine ofRs. 10000 to each student to be deposited along with submission of affidavit by the student and parents – Written warning by the Principal OR Debarring for a minimum period of one year / rustication / expulsion besides legal action, if applicable, on finding faulty / guilty after investigation and as per opinion / recommendations of designated enquiry / investigation authority / committee.

B. Fightwithout weapon:

Any act of threat or display of violence affecting body which includes but not limited to slapping, scuffling, assault & battery / unlawful physical violence, provocation for violence, promoting enmity / physical harm etc.

Suspension and enquiry – Fine of Rs. 25000 to each student to be deposited along with submission of affidavit by the student and parents – Written warning by the Principal OR Debarring for a minimum period of one year / rustication / expulsion besides legal action, if applicable, on finding faulty / guilty after investigation and as per opinion / recommendations of designated enquiry / investigation authority / committee.

C. Fight with weapon:

Any act of fighting / violence affecting / hurting human body which includes but not limited to fighting / violence with possession / handling / use of items / substance(s) / means /things etc. causing injuries to body or abetting / participating for the same.

- 2. The above policy is applicable to all the students of institutes / schools / colleges of Baba Farid Group of Institutions.
- 3. Any act of commissions or omissions of any student / students, at or from any place / area which includes but not limited to BFGI Campus, Main Gate of Campus, BFGI Transport / Buses, outside / outstation tours / programs / functions and / or attracting other student(s) / employee(s) of BFGI / guest(s) or visitors or any other, violating the policy shall amount for action as per rules of said policy.
- 4. Offence against violation of rules and regulation of aforesaid policy shall refer to overall track of concerned student in the institute, during investigation / enquiry.
- 5. Suspension shall include handing over the student to the parents / guardians immediately on release of suspension orders duly acknowledged by the parents.
- 6. Enquiry shall include the joining / participation of parents (father or mother in case father is not available in the country or not alive) / guardians (in case parents are not available in the country or not alive or guardians in place of parents) on calling of enquiry / investigation committee / authority. Enquiry Committee/Authority shall take ex-party decision in case parents fail to attend / join the investigation.
- 7. The Chairman of Enquiry Committee shall submit Inquiry Report within seven working days from the date of receipt of orders for enquiry from competent authority.
- 8. The Principal or any designated authority shall have power(s) to impose all or any fine/penalty and / or punishment in accordance with the aforesaid policy.
- 9. Decision of concerned Principal / designated authority, regarding un-known acts / acts other than above acts violating rules and regulations / policy, shall be final.

- 10. Noncompliance of orders of fine and / or punishment by the concerned student with in stipulated period shall conclude / tantamount for further action by the concerned / designated authority without further notice in this regard and student shall be responsible and liable of the consequences in that circumstances.
- 11. Any kind of acts committed by student and action taken by authority shall be recorded in the personal file of student.
- 12. The above policy is effective from 01.04.2013 and shall be applicable / amended from time to time in accordance with and as per rules & regulations of BFGI as well as law of the land.
- 13. The above policy is displayed on notice board(s) of institute(s) / school / college(s) of BFGI campus for necessary information / notification and follows of concerned students.
- 14. The Section and other headings contained in this policy in this policy are for reference purpose only and shall not affect the meaning or interpretation of this policy.
