**MEMORANDUM OF**  
**BABA FARID VIDYAK SOCIETY**

1. Name of the Society **BABA FARID VIDYAK SOCIETY.**


2. Registered Office Bathinda or where the society decides time to time. It will be intimated to the registering authority within ten days from the date on which change is made.

3. Area of Operation The area of operation of the Society shall be throughout India as well as outside India.

4. **Aims & Objectives of the Society:**

- a. Society is formed to provide, start, establish, run takeover, manage, maintain Institutes, Schools, Colleges at rural areas, semi rural areas & urban areas, for pre-primary, primary, middle, secondary, senior secondary, higher education, Nursery Teacher Training, ANM/GNM/ B.Sc. Nursing or courses seeking Recognition from Bar Council of India, NCTE, India Council of Nursing, or any other recognized Institution of Government of India, or any State adult education, professional courses, courses offered by National, International Institutions, and other educational training program for children, youths and old age persons of all ages, without any distinguish of caste, creed, gender, religion and in the interest of the mankind in general and to issue the certificate of training, education etc.
- b. Society shall provide education at concession to handicapped and other students if they produce recommendation certificate of physical inability from local District CMO subject to the academic record of the student.
- c. Society shall also impart vocational education by opening vocational training centers to help the nation in eradication of unemployment, to promotion and also establish & adopt audio/visual aids & applied methods.
- d. Society shall work for National integrity & concepts to improve education system and to aid or established any institution or adopt means for promotion of any art, science or any other field of education.
- e. To open libraries, reading rooms and to aid or establish, takeover or collaborate with any institution or school or association for physical, mental, spiritual, educational development, uplift of intelligence or its development within India or abroad.
- f. To arrange, establish, manage training institutions for Typing, Short-hand, Computers, Fine Arts, Crafts, Music, Painting Fashion Designing, Modeling, Dancing, Yoga, Physical Education or for any other professional training programs and to provide degree/diploma certificate.
- g. To arrange or provide first aid such as medical aid and such other assistance necessary for living to the needy persons who are otherwise incapable or handicapped or mentally or physically retarded persons in general.
- h. To conduct research in education, science, etc. or any other discipline or subject relating to education or not.
- i. To establish or run in any part of India or abroad, institutions, colleges, schools, training centres, etc. for any type of education be imparted to the students orally or through post, or other media and to conduct examinations and to award degrees or certificates.
- j. To provide foods, clothes, stationery, transportations, libraries, labs, reading rooms, hostels, play grounds, swimming pools, auditoriums, gyms, or to conduct seminars on education or others.




- k. To engage, employ or hire appropriate staff, workers, employees, legal experts, professionals, attorneys, managers, agents at the reasonable remuneration, salaries, wages, honorarium, stipend fees to run the society efficiently and to achieve the aims & objects.
- l. To collect or receive funds or donations through fees from the students to improve the arrangements required/necessary to uplift of education and standards of education.
- m. To invest money in Government or Semi Government financial institutions, Banks in the form of fixed deposits or in any other form and in case of necessity to receive the deposits against deposits or loan against deposits.
- n. This society is non-political, non-commercial and non-profitable.
- o. To arrange or provide timely help or aid to the families of the workers of the society.
- p. To control pollution and to make the aware of the methods and devises to control of pollution.
- q. To control population of the country and to make aware people of the various family planning measures.
- r. To take such steps, actions which are necessary to achieve the above aims and objective of the Society, including to raise funds and subscriptions, grants, loans, financial assistance from Center Govt. Banks (Nationalized or Private) Khadi & Village Industries Board, Local authorities, co-operative societies, incorporated or not or any individual or group of individuals/persons and to buy sell, exchange, transfer, mortgage or hypothecate moveable or immovable assets/properties etc. or, to produce or sell goods, sale or mortgage of movable or immovable properties, assets, to obtain securities, sureties, to run the society efficiently and to achieve the aims and objectives of the securities, sureties, to run the society efficiently and to achieve the aims and objectives of the society, and to open accounts with the National, Private Banks, or Financial institutions, Post offices, and to enter into any kind of contract to promote the activities of the Society.

All the incomes, earnings, moveable or immovable properties of the society shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profit or in any other manner whatsoever to the present or past members of the Society or top any person claiming through any one or more of the present or past members. No member of the society shall have any personal claim or any personal claim or any moveable or immovable property of the society or make any profit whatsoever by virtue of his/her membership. However the members actively engaged in the affairs, works, any activity of the society shall be entitled to the reasonable remuneration, along with T.A. & D.A. or other expenses for attending meetings or out of pocket expenses as may be decided by the Executive Committee of the Society.

5. In accordance the provisions of the Registration of Societies Act, 1860 the responsibilities for governing the work of Baba Farid Vidyak Society, Bathinda is entrusted to the Executive Committee. The present members of the Executive Committee are as under:-



